Grant Awards to Address Payment Reform Implementation Barriers

- 5-7 grants
- Up to \$80,000 each
- To implement payment and care delivery reform initiatives
- The lessons learned from each project will be shared widely by SNAC to inform the broader safety net community.





Learning Collaborative Scholarship

• SNAC will support scholarships for up to 60 organizational teams to participate in one or more collaboratives. A scholarship (not conferred as a financial award) will cover the cost of tuition for one learning collaborative. As with the grant opportunity, this is a competitive process.
